This office also has a California Registered Professional Engineer. All locations have 24-hour on-call after hour's service.

10. We have a fleet of over 80 service/construction vans and a flatbed truck at each location for equipment transportation.

Our Oregon office is located in Milwaukie, Oregon at 99E, one block south of the Tacoma Street overpass.
